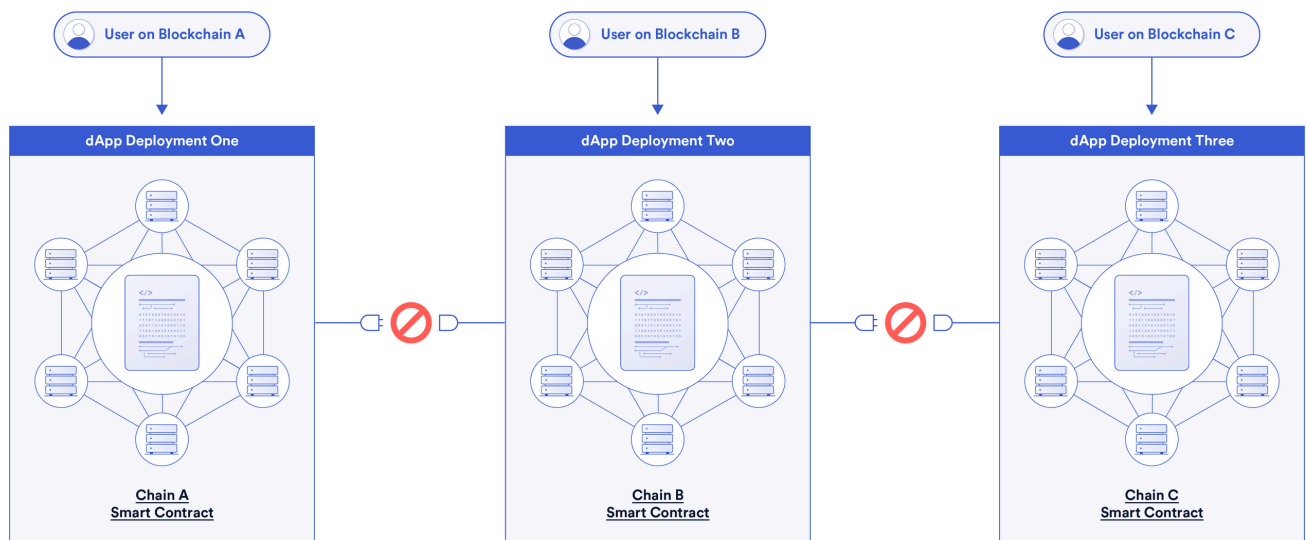

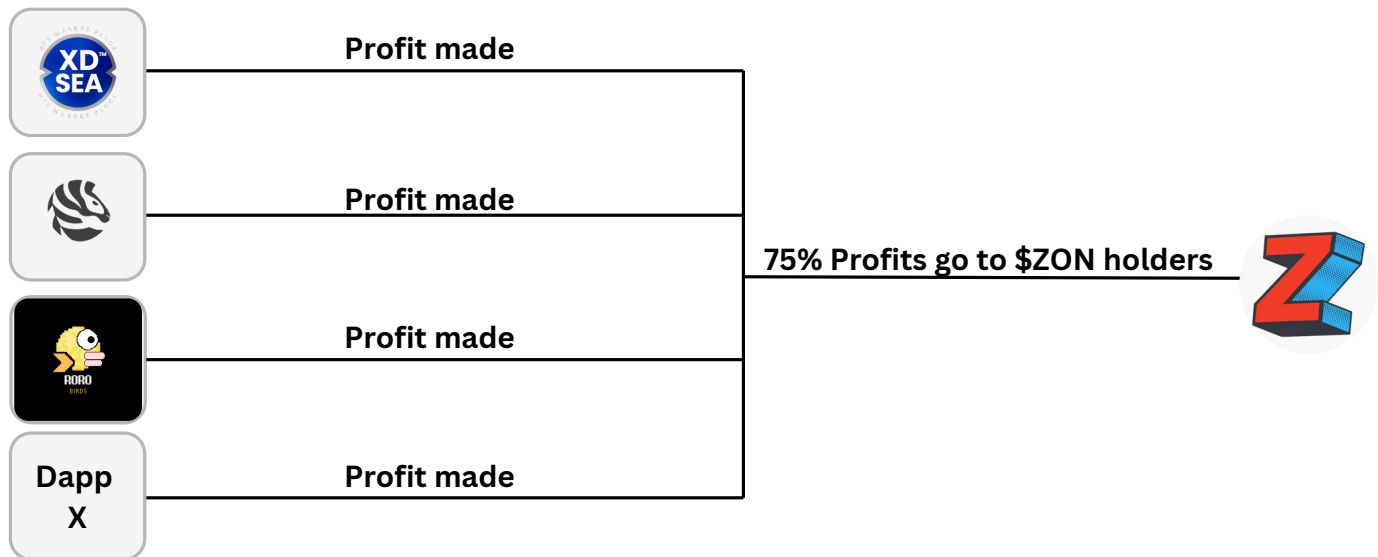

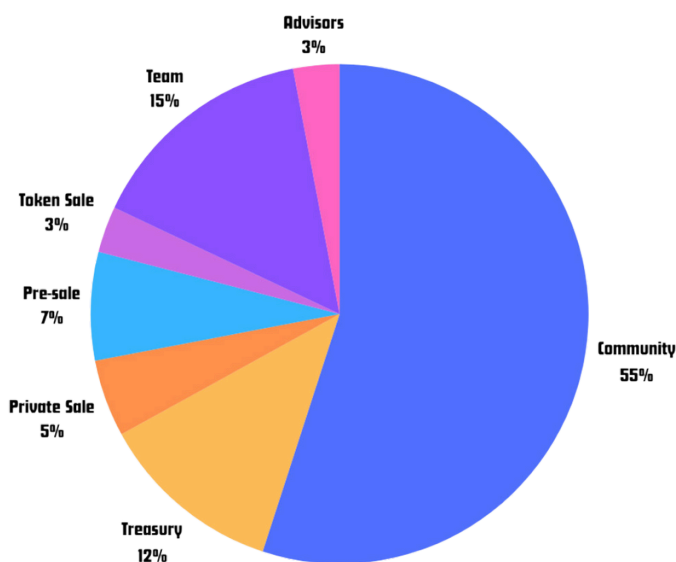

### Private Sale (5%):

This 7% will be reserved for the community, high-net individuals and institution

### **Token Sale (3%):**

#### ***Token Allocation: 30,000,000 Tokens***

This 3% will be available to everyone participating in the public round

### **Community (55%)**

#### ***Token Allocation: 550,000,000 Tokens***

The Community would be allocated the majority of the token to facilitate various sort of value generation events in the community ranging from, staking, yield farming, and airdrops.

#### *Liquidity and Market Making (20%):*

- Creation of liquidity pools on decentralized exchanges
- Incentive programs for liquidity providers.

#### *Community Development (30%):*

- Initiatives to foster community growth, engagement, and education.
- Community forums, AMAs, and events to enhance interaction.

#### *Marketing and Promotion (25%):*

- Comprehensive marketing campaigns targeting both crypto enthusiasts and a wider audience.
- Partnerships with influencers and strategic marketing channels.

#### *Incentive Programs (Staking, Yield Farming, Airdrop) (25%):*

- Farms: allocated reserves would stand at 10% of the community reserves
- Staking: allocated reserves would stand at 10% of community reserves
- Airdrop: allocated reserves would stand at 5% of community reserves

### **Treasury (12%):**

#### ***Token Allocation: 120,000,000 Tokens***

The Treasury fund will be used for securing partnerships and bounty programs with minimal funds flowing through to day-to-day operations not covered by the team tokens pool.

### **Advisors (3%):**

#### ***Token Allocation: 30,000,000 Tokens***

Vesting Period: 2 years

Cliff: 4 Months

Release Schedule: 25% quarterly after the cliff

**Team (15%):**

**Token Allocation: 150,000,000 Tokens**

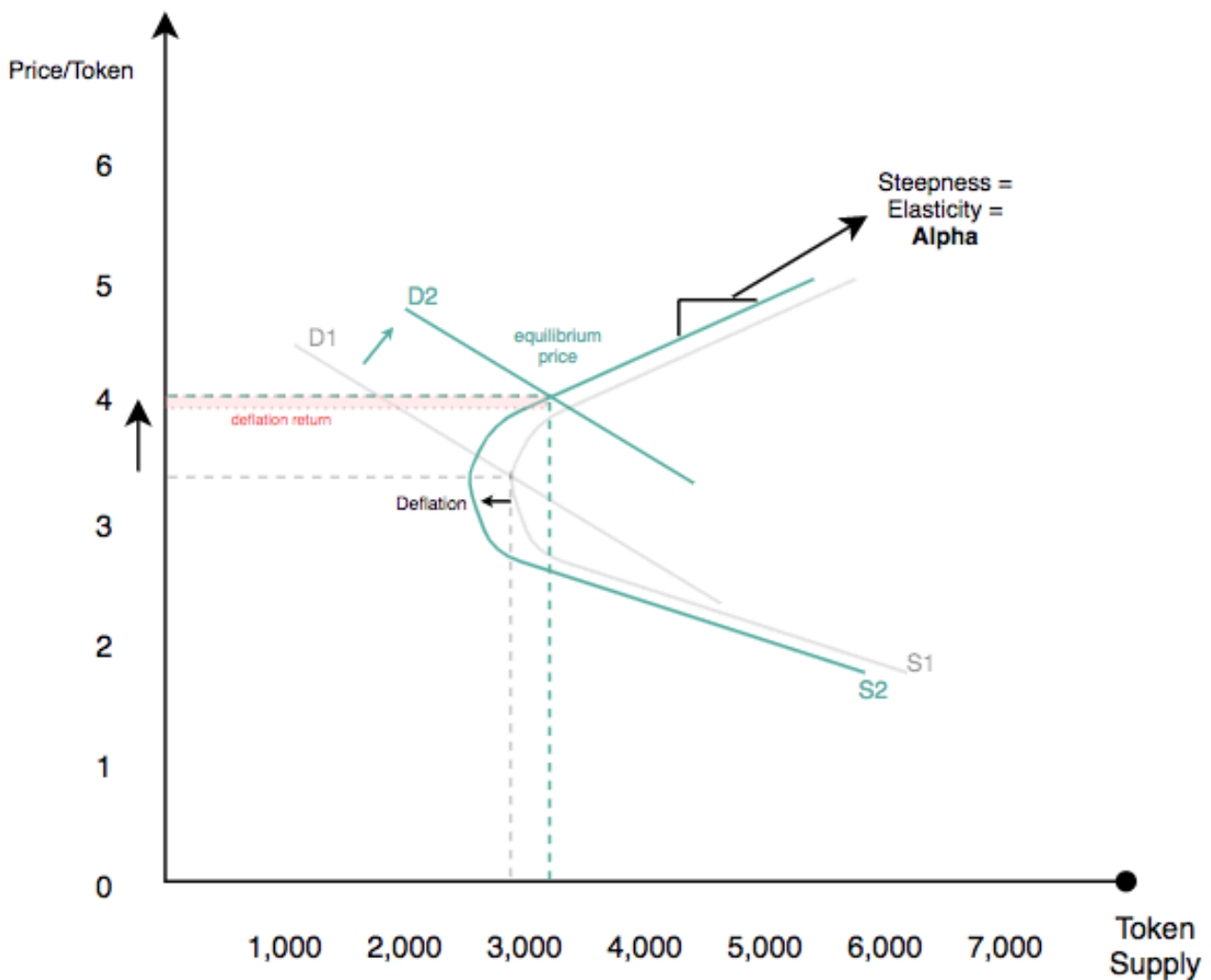
Vesting Period: 4 years

## Deflationary Model

**Limited Supply:** Ensures stability and potential value appreciation



Some movement from D1 to D2 and full movement from S1 to S2 is from the actions of the company. Steepness/elasticity of the S lines is determined by the token holders (strong or weak hands in crypto-speak)

## FAQ'S

### **1.Q: What is the purpose of the Private Sale?**

A: The Private Sale is reserved for early supporters, including Seed, VC, Private, Strategic, KOL, and Angel Rounds. It provides exclusive access to tokens at a discounted rate, fostering initial project support.

### **2. Q: How can I participate in the Pre-Sale?**

A: Participation in the Pre-Sale involves registering with us. Detailed instructions will be provided closer to the Pre-Sale date.

### **3. Q: What benefits do token holders receive in the Community category?**

A: Community token holders enjoy various benefits, including opportunities for staking, yield farming, airdrops, and active participation in shaping the project's future through governance.

### **4. Q: How are Team tokens vested?**

A: Team tokens follow a 4-year vesting schedule with a 1-year cliff. The first 25% is released on the Token Generation Event (TGE), followed by 25% annually after the cliff.

### **5. Q: Can I earn tokens through staking in the Community category?**

A: Yes, the Community category, comprising 55% of the total supply, allows participants to earn tokens through activities such as staking, yield farming, and airdrops.

### **6. Q: What is the purpose of the Treasury category?**

A: The Treasury category, constituting 12% of the total supply, is allocated for securing partnerships, executing bounty programs, and funding other strategic initiatives to support project growth.

### **7. Q: How are Advisors compensated for their contributions?**

A: Advisors receive tokens as compensation for their thought leadership and ongoing contributions. The vesting period is 1 year with a 1-quarter cliff, followed by 25% quarter releases.

A: Once the Token Sale period concludes, tokens may be available on secondary markets. However, it's crucial to exercise caution and use reputable platforms.
